







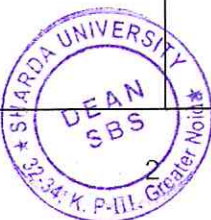

### The Concept of International Taxation

Country – A (India)

Governing Tax Laws – Indian Income tax Act, 1961 (alongwith Rules)

Tax Treaty :  
- For avoidance of double tax,  
- Promotion of trade

Country – B (Singapore)

Governing Tax Laws – Income tax Act by Inland Revenue Authority of Singapore

- India has over 90 Tax Treaties (Double Tax Avoidance Agreements) with different Countries,
- DTAAs with specific Countries prescribe specific provisions – lease of Aircraft from Ireland to India is tax exempt in India, provision of equipment from Sweden to India will be tax exempt in India,
- Taxpayers are given an option to get covered in the provisions of the Country's local tax laws or DTAA, whichever is beneficial to the taxpayer
